radually all over the world, the French research institutes based abroad are getting con cerned with a reform in their functioning. As far as India is concerned, the annual scientific committee of CSH AND IFP, held on 19th and 20th May in Paris, has been the occasion to tune up and recall the main consequences and advantages of an undefgoing reform. The latter tends to increase and deepen the support, links and exchanges with large French (and European) research agencies.

The main change is that the five Asia-based French research institute (CEFC in Hong Kong, MFJ in Tokyo, IRASEC in Bangkok, and of course the CSH and IFP) now share the same scientific committee. With its 18 newly nominated members, the disciplimary focus has been strengthened, through a 'critical mass' effect, while scientific exchanges are increased across cultural areas. If one of the key objectives of the Institutes remains the collaboration with local research units, the common scientific committee is also a tool for sharing views in different but often complementary contexts.

But of course, research is also about means and evaluation, as well as with preparing the future through training of young researchers. In that respect, the reform of the centres includes in the near future a doubling of fellowships offered to young Ph.D students, as well as the support by large research agencies for a better dissemination and critical assessment of the publications of our centres.

Ultimately, and as far as our Institutes in India are concerned, the objective at stake for the years to come, will be to attract more French and European researchers to work on India, while favouring reciprocal exchanges. The reform gives a tool for the former, through possibilities of association with the CNRS (French National Centre for Scientific Research), either under joint units, joint laboratories, joint temporary programmes or financing of projects. As far as the reciprocity is concerned, we have to be imaginative with our direct research partners. Among others, the CNRS regular call for projects favour now mixed international pluridisciplinary teams, or the EU-sponsored 'Asia Links' programme offers similar facilities.

The reform of the centres, that way, is not a mere institutional change, but does offer a scope for deepening Indo-French research collaboration, at the condition that we imaginatively use it under a diversified and rich set of opportunities.

The scientific committee of May, followed by a meeting of the 30 French Centre's directors around the world in July has confirmed it: the international network around French institutes in general, and our geographical/cultural zone in particular offer a vast space for questioning the world and its evolutions, for mutual benefit. Within this, the effort of 'indianisation' of our two institutes has been well recognised and appreciated. That way, and with the appropriate tools, there are no reasons to be shy in the research we collectively propose and conduct.

#### SAIVA STUDIES IN PONDICHERRY

Certainly in the world of Sanskrit studies, it is the initiative that led to the publishing of the agamas and Sanskrit exegetical works of the Saiva Siddhanta that, so to speak, put the French institutions of research in Pondicherry on the map. Thanks to the enthusiastic efforts of a research team under the now renowned N.R. BHATT, a very considerable collection of manuscripts was gathered together in the IFP (8600 on palmleaf alone), and many publications that drew upon or were very largely based upon the Saiddhantika manu-

scripts of this collection have resulted. It was thus the French and Indian scholars of Pondicherry who for the first time attempted a thorough and broad-based study of the ideas and rituals of the pan-Indian Sanskritic Saiva Siddhanta and made many of its texts available to the scholarly community. Two works stand out perhaps as intellectual monuments among the Saiva publications: N.R. BHATT's edition of the formative 10th century exegete Ramakantha II's magisterial commentary on the Matangaparamesvaraagama (PIFI 56 and 65) and Hélène BRUNNER-LACHAUX's richly annotated translation of the 11th-century Somasambhupaddhati (PIFI 25. 1-4).

Saiva studies are still being actively pursued in

Pondicherry. A first edition of an unpublished pre-10th century Siddhantatantra, the Parakhyatantra, is now ready for press (prepared by Dominic GGODALL (EFEO), together with an annotated translation – the first complete English translation of an agama. A study group meets daily in the Pondicherry centre of the EFEO, focussing at the moment particularly on a dialectical work, the 10th-century commentary of Ramakantha on the Paramoksanirsakarika ('Verses that refute the conceptions of liberation of rival schools'), of which a critical edition and annotated translation is being prepared by Dominic GOODALL, Anjaneya SARMA (EFEO) and Alex WATSON (Oxford). But other, unpublished Saiddhantika texts are also being studied together, notably the 12th-century Prayascittasamuccaya of Trilocanasiva (edition under preparation by R. SATHYANARAYANAN (EFEO).

The group's number is regularly swelled by long-term or short-term visitors with interests in Saivism. At the moment these include: Whitney COX (Chicago), Mei YANG (Hamburg), Dr. Alex WATSON (Oxford), Dr Timothy LUBIN (Washington and Lee), Dr. Harunaga ISAACSON (Pennsylvania), Dr. Godabarisha MISHRA (Madras).

#### **CARBON DYNAMICS IN TROPICAL FORESTS**

There is a global concern that carbon dioxide is being released in large quantities and enhancing the global temperature. Tropical forests are considered as sinks of carbon dioxide and therefore there is large interest in developing and conserving forests in the tropics that helps in carbon sequestration. However, the data on carbon assimilation is largely lacking in the tropical forests. Results of carbon stock dynamics monitored in Western Ghats, Karnataka, for 10 years with different management systems and forest types indicates that in general the carbon stock has enhanced during the study period with an average growth of 1.008 t/ha/year. However, there were differences in carbon stocks in different management regimes. The minor forests that are subjected to intense human pressures had a negative growth rate i.e., 0.237 t/ha/year, while the reserve forests have carbon assimilation rate of 1.31 t/ha/year. This indicates that the human pressure has certainly decreased the carbon accumulation in the forests of Western Ghats. Despite the anthropogenic pressure, the minor forests have higher carbon accumulation through recruits as compared to the reserve forests. Thus it is suggested that a management strategy is needed to look into enhancing recruitment patterns in minor forest that would become future carbon stocks.

### INTELLECTUAL PROPERTY IN THE INDIAN CON-

The project dealing with intellectual property looks at the legal point of view as well as that of the anthropology of law, as compared to the other systems, particularly European. These themes will help tackle issues like those of industrial property, biodiversity, interventions on living beings, ethic problems etc. India is an ideal place, legally as well as in actual practices in these matters, showing an alternative and always representing an example to other developing nations.

Researchers in social sciences are aware that questions pertaining to Intellectual Property get more importance. Courts and professional institutions deal with demands in order to ensure acknowledgement of new collective and individual rights on traditional cultural goods and values collectively shared. This tendency shows a need for protection of biological as well as cultural resources. The concerned groups are asked to use procedures and laws to enforce theirs rights and to form chartered associations. The lawyers are thus concerned in their capacity as experts and anthropologists because of their knowledge about traditional cultures.

In this scientific perspective, the Institute occupies a central place, not only due to its evident position, but also due to its programmes, its setup, its teams and its experience in the field of publications. The project will help in a documentation, which will be useful for specialists and the informed public, to develop a professional network and to publish the works carried out.

## INDIA IN THE WORLD TRADE ORGANIZATION'S DISPUTE SETTLEMENT BODY

The question is whether India has a general strategy (that transforms dispute settlement into a trade policy tool) or, on the contrary, an opportunist approach, reacting on a case to case basis. This issue cannot be dissociated from the internal Indian dispute settlement system and is suggestive of two questions: Which administrative authority decided on lodging a complaint and what are the procedures followed? What is the degree of involvement of Indian exporting companies in the initiation of a claim (a comparative approach with European and American regulations on obstacles to trade could be undertaken), on eve of certain non-governmental organizations? Based on these analyses, we will endeavour to identify the major fields of interest for India, fully aware of the fact that a large share of these is based on three sectors, respectively covered by the Agreement on Trade-related Aspects in Intellectual Property Rights, the Agreement on Agriculture and the Agreement on Textiles an Clothing.

## THE SUCCESS OF JOINT FOREST MANAGEMENT: A VIEW FROM THE VILLAGE

When Joint Forest Management (JFM) was launched in 1991 to ensure a sustainable future for Indian forests, it emphasized that management should primarily aim at meeting the basic needs of women and poor people and should develop their capacities. Participatory users groups were to be constituted.

Nowadays, if forest cover is broadly increasing all over the JFM zones, the second aspect of JFM, i.e. putting forest-dependent people in an active role and as first beneficiaries, is not so much focused. The aim of this M.Phil is to study how the policy has been understood and translated at the local level. The main hypothesis is that in allowing equal rights of participation to every community member, the local elite will be able to take

control of the user groups and thus could neutralize the improvement of the more dependent people's situation. Field study is conducted in two tribal forest communities from Southern Madhya Pradesh.

Seminar "The European Union in World Politics" was co-organised by the CSH, Delegation of the European Commission, Indhira Gandhi National Open University, Fundacio Oriente and JNU EUSP at IIC,  $22^{nd}-23^{rd}$  May.

D. SENGUPTA organised a **two-day seminar** (29<sup>th</sup> – 30<sup>th</sup> June) "The NDA's Foreign Policy" (along with SPANDAN) in School of International Studies, JNU, New Delhi. Second International Intensive Sanskrit Summer Retreat: Last year in July, the Department of Indo-European Studies of Eötvös Lorand University, Budapest organised the first International Intensive Sanskrit Summer Retreat in Romania. 20 students and scholars from Europe and Japan met together in the small Transylvanian market town of Csikszereda (Miercurea Ciuc) for two rewarding weeks of intensive reading of Classical Sanskrit texts from three genres: kâvya, tantra, and sâstra.

Following the popular success of last year's venture, the Pondicherry Centre of the EFEO decided to host the sequel: the second International Intensive Sanskrit Summer Retreat (21st July – 4th August). Just under 30 participants, from India, France, Hungary (supported by the ICCR), Romania, England, China, Japan, Korea, Poland and the USA, attended.

Three reading sessions took place each day, devoted to kâvya, tantra, and sâstra. Each of the texts chosen were one of which manuscripts had been gathered and collated by a participant of the Retreat: Raghuvamsa 8 with Vallabha's commentary, the Siddhântasamuccaya of Trilocanasiva, the section of the Nyâyamanjarî of Jayanta that deals with the authority of scriptures other than the Veda, the Kuttanîmata of Dâmodara, the Bhramaharasadhana of Ratnakarasanti, and the Paramoksanirâsakârikâvrtti of Râmakantha. The texts were proposed by Dr. Kei KATAOKA (University of Tokyo), Dr. Dominic GOODALL (EFEO), Dr. Harunaga ISAACSON (University of Pennsylvania) and Csaba DESZÖ (University of Budapest).
